The old "Sam's Club" location owners rejected an offer for a parcel; negotiations will continue.

Golf Manor held a meeting on the 11th regarding The Little Miami Joint Fire & Rescue; all council members are supportive of a merger and will hold a vote at a meeting scheduled for September 25th.

Roe Avenue construction continues with curbing beginning ahead of schedule. Residents are facing some parking challenges as expected.

We are seeing many new residents seeking available tax abatements; some are coming from Madison Place. Requirements for CRA Residential Applications include a notarized list of improvements and costs and certificate of occupancy.

Bike Path Study results are expected any day.

We attended a business retention visit to CBT with REDI and HCDC to address any issues and offer assistance from the Township. CBT is happy with its Township location and services.

We met with the tax administrators for the JEDZ to discuss improved reporting.

We have locked in rates that are 9% less than what Duke Energy provides. Residents can call Constellation Energy to sign up.
