Stacey Bon shared issues she is having with a neighbor violating the noise ordinance and questioned our noise ordinance compared to neighboring policies; i.e. Mariemont. Mr. Lemon indicated that the Township would offer assistance should the problem persist.

Administrator's Report

Mr. Lemon's report was included with the meeting packet and is available for public inspection.

Mr. Lemon shared details regarding several items including the Comprehensive plan status; a public meeting was held prior to the Trustee meeting. We should be able to submit the new plan in December and have approval in January.

Bid for Waste Collection and Recycling was opened. Rumpke was actually the only company to turn in a bid; however, we will actually pay less through 2020 than we paid in 2011. This rate is among the lowest, if not the lowest, for comparable services in the area.

LMJF&R merger will likely pass at the meeting on the 11th; if all goes as we anticipate we could actually be in a position to lower resident's taxes in the years ahead. Mr. Kubicki expressed the gravity of this decision and the length and breadth of exploration to arrive at a decision. Mr. Kubicki thanked Mr. Lemon for his counsel and oversight of this merger and its potential benefits to the Township.

The Bike Path Study will be about 1 month behind schedule; Great Parks relayed the information that the consultant has had a medical issue.

JEDZ revenues are up 22% from last year and we hope to see that trend continue.

Roe Street construction continues; we have received some complaints but mostly compliments about the quality of work. We expect to finish four weeks ahead of schedule. There was misinformation disseminated during the election campaign about overtime costs by the contractor; as our agreement indicates, any overtime will be absorbed by the contractor.

We held three Township Meetings educating residents about the LMJF&R merger and other items happening in the Township. Many residents expressed appreciation for the meetings being held in the neighborhoods and for the information.

Mr. Kubicki indicated that we will listen to interested parties in the Medical Marijuana Dispensary issue and discuss at a later date.

LMJF&R Report

Mr. Kubicki reported that there is a meeting tomorrow (10/11/17) and the merger will likely pass.
