Mr. Lemon highlighted several items including that we are diligently striving to keep the Bike Path Extension moving forward. In meeting with Great Parks, 50 West and other area businesses there was great support for plans that include a canoe launch and exercise stations that would be maintained by Great Parks. Phase 1 might be complete this year.

There is a proposed "Road Diet" that identifies exact measurements of paths and barriers; essentially turning this section of Wooster Pike into a two-lane road with bike paths and sidewalks on both sides as

well as protective barriers on both sides. ODOT and Great Parks are supportive of the Road Diet. ODOT would also like to study traffic counts and simulations of traffic counts at various times of day. Overall, everyone involved seems to be on the same page.

Mr. Kubicki added that he spoke to hopeful Medicinal Marijuana license recipients who are expecting to have announcement by the end of spring.

Mr. Kubicki and Mr. Lemon met with residents of Williams Meadow to discuss the proposed Wooster Pike Crossing. Overall the residents seem to be supportive and we are ready to move ahead with planning phase including presenting plan to ODOT.

Speed signs are ordered and should arrive in 2 to 3 weeks.

St. Patrick's Day celebration was a huge success thanks to the hard work of the trustees, staff and the Sherriff's office.

Cinco De Mayo planning is in full swing. There will be food trucks, live music, piñatas and televisions for live Derby feed. Post cards will be inserted in the newsletter. Mr. Kubicki thanked our sponsors.

Mr. Lemon was asked to serve on the board of the Community Improvement Corporation of Greater Cincinnati for 5 years; Mr. Lemon agreed to serve for one year and will assess after one year.

David Olson, Director of LMFJR is moving to Boston; the trustees will need to appoint a new Director. Mr. Kubicki thanked Mr. Olson for his 20 years of service.

Les Hemingway filed a request and followed our process to receive approval for a street light on Cambridge Avenue which Duke will install in the next few weeks after we approve in new business.

We have provided notice in the newsletter of our new process regarding residents requesting wood chips and compost. Our procedure seems to working well and will continue.
