The Columbia Township Regular Board meeting was called to order by Trustee David Kubicki at 6:00 p.m.

## **Approval of Minutes**

Mr. Kubicki made a motion, seconded by Mr. Kritikos to approve Regular Meeting Minutes of August 14, 2018. All present voted yes.

## **Open Forum**

Jayne Payne wanted to thank the Trustees and Administrator for the quick response to property clean up requests and asked about procedures involved in removing a particular vehicle that seems to meet "junk" criteria. Mr. Lemon will investigate and reply accordingly.

Les Hemingway proposed the idea of the Township awarding beautification certificates to property owners. The Trustees and Administrator will look into organizing. Mr. Hemingway also inquired about the possibility of paying the Mariemont Police to patrol Madison Place due to a recent shooting on Blaney. Sgt. Schlesinger provided follow up on the shooting; it was an isolated incident. Both Mr. Kubicki and Mr. Kritikos pointed out that alternatives have been explored and will continue to be looked at. Mr. Lemon added later that we are also exploring adding personnel as revenue is generated by the medicinal marijuana dispensaries. Mr. Hemingway also had a question about a possible tax increase to cover fire and rescue services. Mr. Lemon encouraged Les and other in the community to attend the next Fire Board meeting to address that question. Mr. Kubicki assured residents that we are sorting through this very complex situation.

Panera Bread is well under way in construction; we are seeking help from the CIC to help fund the waterline improvements for the site. The annexation of Seven Hills property is moving forward. We hope to put the Bike Path extension development out for bid soon. 2018 street paving projects have begun on Lucille and other streets and expect to be complete in 30 days. We have reached an agreement with the Sherriff's Department for a three-year contract. Our Audit is almost complete; all questions raised should be settled and there are not findings. The JEDZ audit has begun and there are some questions regarding Fairfax's accounting. Township Boundary Signs are being installed and so far, the feedback has been good. We will be increasing the number. All four radar signs are operational
