The Columbia Township Regular Board meeting was called to order by Trustee David Kubicki at 6:00 p.m. **In attendance**

Those Trustees in attendance were David Kubicki, Susan Hughes and Chris Kritikos. Township Administrator Michael Lemon and Administrative Assistant Kimberly Gray were also present. The pledge of allegiance was recited.

Approval and Signing of Minutes

Mr. Kubicki made a motion, seconded by Ms. Hughes to approve Regular Meeting Minutes of May 14, 2019. All present voted yes.

Open Forum

<u>Carl Jones</u> began to recount an alleged incident that took place at the township office. Mr. Kubicki pointed out that this is not the proper venue to discuss it and that Mr. Jones could go to the police if he has an issue. <u>Mike Tighe</u> asked if the Woeste group employs residents of Madison Place and if they can set up a training facility for residents. Mr. Tighe also asked why we couldn't compromise on the 4 houses being rezoned to commercial. Mr. Kubicki pointed out that there was a huge compromise in the plans and that we made the best deal. Ms. Hughes and Mr. Kritikos agreed with the deal that was reached and the residents were listened to and the compromise was substantial.

<u>Stacy Bryant Rose</u> asked what is the process for approval of the project. Mr. Lemon explained that after receiving the staff report he would ask the Trustees for input and then send a letter to the Rural Zoning Commission. Ms. Rose also asked about the Township's Arborists; she would like to speak to them about how the project might affect our standing as a Tree City USA. to review the grant application and determine the financial accountability of the district. Mr. Kubicki told her to call the office to speak to them. Ms. Rose also asked for the schedule of when the houses will be torn down. Mr. Kubicki was not aware of the timeline.

<u>Rose Ellen</u> asked why the Trustees can't have the Woeste Dealership move to another location on Columbia Township. Mr. Kubicki explained that is not our role and that the Trustees are doing their best to keep business owners and residents happy. To fight an existing business would not be productive and we would not win.

<u>Jen Bryant</u> discussed the revised landscaping plans for the Woeste development proposed in the rezoning application letter.

<u>W. Cameron</u> presented a letter to the trustees regarding the Woeste development. Mr. Cameron read the letter.

Bruce Kennedy also discussed the Woeste expansion and the history of the development.
