

RESOLUTION NO. 20- 17, 2020
COLUMBIA TOWNSHIP, HAMILTON COUNTY, OHIO

**ESTABLISHING AN ON-STREET, NON-PERSONALIZED DESIGNATED
HANDICAPPED PARKING SPACE ON TOWNSHIP STREETS**

WHEREAS, Revised Code § 505.17 authorizes Columbia Township, Hamilton County, Ohio (the "Township") to make such regulations and orders as are necessary to control vehicle parking in the unincorporated area of the Township;

WHEREAS, by adoption of Resolution 20-17, the Board of Trustees of the Township (the "Board") adopted certain parking regulations pertaining to handicapped parking, including on-street, non-personalized handicapped parking on public streets abutting residences, which regulations are set forth in the Handicapped Parking Policy (attached as Exhibit A to Resolution 20-17);

WHEREAS, the Township Administrator has determined there is a need for establishing an on-street, non-personalized Designated Handicapped Parking Space (as that term is defined in Resolution 20-17) on several township streets directly in front of the following addresses to assist a handicapped citizen who resides at:

6944 Roe
6903 Grace
6952 Roe
6903 Windward

WHEREAS, it is in the best interest of the Township and its citizens to establish an on-street, non-personalized Designated Handicapped Parking Space on these streets subject to Resolution 20-17 and the Handicapped Parking Policy; and

WHEREAS, the Board, upon majority vote, hereby dispenses with the requirement that this resolution be read on two separate days, and hereby authorizes the adoption of this resolution upon its first reading.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees of Columbia Township, Hamilton County, Ohio, for the benefit and welfare of Columbia Township and its citizens, hereby establishes an on-street, non-personalized Designated Handicapped Parking Space at:

6944 Roe
6903 Grace
6952 Roe
6903 Windward

BE IT FURTHER RESOLVED, that no person shall stop, stand, or park a motor vehicle in the Designated Handicapped Parking Space at these locations, unless the motor vehicle displays a parking card issued under R.C. § 4503.44 or is being operated by, or for the transport of, a handicapped person and is displaying a placard or special license plate authorized by R.C. § 4503.44;

BE IT FURTHER RESOLVED, that the Designated Handicapped Parking Space these locations, established by this Resolution shall automatically be removed and terminated upon the earlier of the following events: (1) the person upon whose behalf the Designated Handicapped Parking Space was established passes away; (2) the person upon whose behalf the Designated Handicapped Parking Space was established terminates his or her residence at the subject property for thirty (30) days or more; (3) the person upon whose behalf the Designated Handicapped Parking Space was established fails to pay the annual renewal fee; or (4) the Township Administrator, in accordance with the Handicapped Parking Policy, removes the Designated Handicapped Parking Space.
