# Open Forum -

Christian Dial of Dial Residential, LLC joined the meeting via Zoom to present to the Board the details of a proposed development on Walton Creek Road in Columbia Township. Mr. Dial has requested Hamilton County begin the process of a rezone to change the current B zoning to DD in accordance with Columbia Township's Comprehensive Plan. The proposed development will consist of approximately 32 apartments ranging from 650 to 1,650 square feet. The development will provide a great opportunity for residents to take advantage of all the walkable spaces currently available and in the planning stages. Building heights will be no taller than 3 stories and will focus on a design that pays respect to the surrounding nature.

Mike Tighe sent an email regarding the Waste Levy coming up for renewal. Mr. Tighe proposed cutting the current homeowners tax millage and utilizing funds from JEDZ and the Dispensaries to make up the difference for our Waste Services. Mr. Kubicki, Mr. Lamar and Ms. Hughes all agreed this was worth looking into and thanked Mr. Tighe for the suggestion.
