The Columbia Township Regular Board meeting was called to order by Trustee David Kubicki at 4:00 p.m.

In attendance

Those Trustees in attendance were Susan Hughes, Brian Lamar and David Kubicki. Township Administrator Melissa Taylor, Fiscal Officer Caroline Heekin and Police Lieutenant Enderle were also in attendance. The pledge of allegiance was recited.

Approval and Signing of Minutes -

Mr. Kubicki made a motion, seconded by Mr. Lamar to approve the regular meeting minutes of April 13, 2021. All Present voted yes.

Open Forum -

Resident <u>Carl Jones</u> sent an email regarding the Little Miami Fire District. Mr. Jones suggested using TIFF economic development funds, as well as existing money in the township general funds. He also proposed that Columbia Township build its own fire station at Ridge-Highland and lease it back to LMJFRD at a low cost. Mr. Kubicki thanked Mr. Jones for his comments and invited him to call for further discussion. Mr. Kubicki explained that while Columbia Township belongs to LMJFRD, they do have their own board who make the decisions regarding services.

Ms. Taylor noted that while Mr. Jones had accurately cited budget numbers he was not correct in suggesting the township may use any public funds such as the general fund for just any purpose. She added public finance is complicated and that the township staff have more than a hundred years of public finance experience combined.

Mr. Lamar, who serves on the LMJFRD board, noted the importance of building relationships with other communities to provide better services for all. Mr. Lamar continues to be optimistic about negotiating affordable contracts with Golf Manor and Deer Park/Silverton fire departments. Mr. Kubicki maintained that building a new fire house creates more problems and consolidating is simply a better financial and managerial solution than creating new independent entities. Mr. Kubicki concluded that township trustees are committed to making informed non-political transparent decisions for the good of the township and region.
