ACCEPTING CONSTRUCTION BID AND AWARDING CONTRACT TO JK MEURER CO. FOR "MURRAY AVENUE EAST RESURFACE"; AUTHORIZING THE ADMINISTRATOR TO ENTER INTO A CONTRACT WITH JK MEURER CO.; DISPENSING WITH THE SECOND READING AND DECLARING AN EMERGENCY

WHEREAS, the bid of JK Meurer Co., 33 Glendale-Milford Rd., Loveland, Ohio 45140 ("JK Meurer") is the lowest and best for the construction of the Murray Ave. East (Plainville Rd. to Berwick Ave.) Resurface Project hereinafter known as the "Project"; and

WHEREAS, the Project is a necessary public improvement to support the Madison Place Firehouse Redevelopment by replacing the failing Murray Ave. surface which is a public access hazard to the Firehouse; and

WHEREAS, the Board, upon majority vote, hereby dispenses with the requirement that this resolution be read on two separate days, and hereby authorizes the adoption of this resolution upon its first reading; and

WHEREAS, this Resolution is hereby declared to be an emergency measure necessary for the preservation of the public peace, health and welfare of the Township; the reason for the emergency is the Township must award the contract at the earliest possible time to meet the schedule to complete the Project before the start of the Madison Place Firehouse Redevelopment Project in July 2021.

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of Columbia Township, Hamilton County, Ohio, for the benefit and welfare of Columbia Township and its citizens, hereby accepts the bid from JK Meurer upon JK Meurer entering into a contract in the amount of \$57,255, and further authorizes the Administrator to enter into a contract with JK Meurer in the amount of \$57,255.


