

RESOLUTION 21-43 2021
COLUMBIA TOWNSHIP, HAMILTON COUNTY, OHIO

**AMENDING RESOLUTION 21-10, 2021, TO INCREASE AUTHORIZATION TO
PURCHASE ROAD SALT UP TO 400 TONS AT \$71.78 PER TON FROM 250 TONS AT
\$69.69 PER TON FOR THE 2021-22 WINTER SEASON; DISPENSING WITH
THE SECOND READING AND DECLARING AN EMERGENCY**

WHEREAS, the Board of Trustees is authorized to remove snow and ice from township roads to protect the lives and property of township residents and other persons traveling within Columbia Township; and

WHEREAS, Columbia Township, by Resolution 21-10 approved March 9th, authorized the purchase of up to 250 tons of road salt for \$69.69 per ton through the City of Cincinnati contract with Morton Salt; and

WHEREAS, Columbia Township now requires up to 400 tons of road salt for the 2021-22 winter season and also to restock borrowed road salt from the 2020-21 season; and

WHEREAS, the Board desires to purchase road salt for the 2021-22 winter season through the City of Cincinnati contract with Morton Salt, 2625 Butterfield Rd., Suite 208E, Oakbrook, IL 60523, which meets all applicable state and local bidding requirements; and

WHEREAS, this resolution is an emergency necessary for the preservation of the public peace, health, safety or welfare to save money and expediate the bidding process to purchase salt at \$71.78 per ton while supplies are available; and

WHEREAS, the Board of Trustees, upon majority vote, hereby dispenses with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

NOW, THEREFORE, BE IT RESOLVED, the Board of Trustees of Columbia Township, Hamilton County, Ohio, for the benefit and welfare of Columbia Township and its citizens, hereby approves the purchase of up to 400 tons of road salt through the City of Cincinnati contract with Morton Salt at \$71.78 per ton for up to \$32,301.




BE IT FURTHER RESOLVED, that the township Administrator and/or Road Superintendent are authorized to sign and file all documents associated herewith as prepared by the Road Superintendent.
