

RESOLUTION 21 – 49, 2021
COLUMBIA TOWNSHIP, HAMILTON COUNTY, OHIO

**AUTHORIZING THE ADMINISTRATOR TO ENTER INTO A CONTRACT WITH ADLETA
CONSTRUCTION TO REPAIR ROAD DRAINAGE SYSTEM AT 6912 AND 6914 GRACE AVENUE,
DISPENSING WITH THE SECOND READING, AND DECLARING AN EMERGENCY**

WHEREAS, Columbia Township solicited proposals to construct repairs to the Grace Avenue road drainage system at 6912 and 6914 Grace Ave., hereinafter known as the "Project," and the Administrator and Road Superintendent recommend that the Board of Trustees accept the proposal from Adleta Construction, P.O. Box 15872, Cincinnati, Ohio ("Adleta"); and

WHEREAS, the Project is a necessary public repair to a section of damaged road drainage infrastructure, specifically inlet gutters and storm pipe between two catch basins, which is a public hazard in Township right-of-way; and

WHEREAS, this Resolution is hereby declared to be an emergency measure necessary for the preservation of the public peace, health and welfare of the Township; and

WHEREAS, the Board, upon majority vote, hereby dispenses with the requirement that this resolution be read on two separate days, and hereby authorizes the adoption of this resolution upon its first reading.

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of Columbia Township, Hamilton County, Ohio, for the benefit and welfare of Columbia Township and its citizens, hereby authorizes the Township administrator to enter into a contract in the amount of \$12,342.00 with Adleta Construction.

Be it further resolved that this Resolution is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety, and general welfare and shall be effective immediately. The reason for the emergency is the Township must award the contract at the earliest possible time to repair the damaged road drainage system and repave the road to restore safety for the traveling public.


