

RESOLUTION 22 - 22, 2022
COLUMBIA TOWNSHIP, HAMILTON COUNTY, OHIO

**AUTHORIZING THE PURCHASE OF ONE 2022 JOHN DEERE CURB RUNNER LEAF
MACHINE TO REPLACE 2000 LEAF MACHINE FOR LEAF COLLECTION
AND RECYCLING PROGRAM, DISPENSING WITH THE SECOND READING,
AND DECLARING AN EMERGENCY**

WHEREAS, the Board of Trustees of Columbia Township, Hamilton County, Ohio provides for the collection, transfer, and recycling of yard wastes, including leaves, within the Township, and maintains an inventory of grounds maintenance equipment, as part of the Township Waste District; and

WHEREAS, the Maintenance Department recommends replacing its 2000 leaf machine with the purchase of a 2022 John Deere Curb Runner Leaf Machine from Dinkmar, 9357 Township Rd. 48, Galion, Ohio, 44833. The Township secured a lesser cost quote of \$55,600 than the State of Ohio purchasing contract (Sourcewell) for \$68,179.25. The 2022 John Deere Curb Runner specifications are detailed on the attached quote sheet; and

WHEREAS, the total estimated net cost of the 2022 John Deere Curb Runner Leaf Machine is \$50,600 after the 2000 trade-in estimated value of \$5,000 is applied to the total \$55,600 purchase. The 2021 budget includes \$45,000 for the new leaf machine but pandemic-related inflation increased the cost.

WHEREAS, the 2000 leaf machine is in deteriorating condition, has been repaired numerous times, and was scheduled to be replaced in 2020 according to Columbia's equipment replacement plan; and

WHEREAS, the Board, upon majority vote, hereby dispenses with the requirement that this resolution be read on two separate days, and hereby authorizes the adoption of this resolution upon its first reading; and,

NOW, THEREFORE, BE IT RESOLVED, the Board of Trustees of Columbia Township, Hamilton County, Ohio, for the benefit and welfare of Columbia Township and its citizens, deems it to be in the best interest of the Township to purchase said equipment and authorizes the Fiscal Officer to draw her warrant on the Township Treasury for payment from the foregoing appropriation upon receiving proper vouchers therefore, and approved by the Board of Trustees.




Be it further resolved that this Resolution is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety, and general welfare and shall be effective immediately. The reason for the emergency is that the inventory of public works vehicles and equipment is nearly depleted due to pandemic impacts (supply chains and manufacturing); the vendor requires an immediate order to provide delivery in time for the Township to conduct staff training this summer and be ready to provide residents with vital yard waste collection services by fall.
