

**RESOLUTION 22 - 31, 2022  
COLUMBIA TOWNSHIP, HAMILTON COUNTY, OHIO**

**AUTHORIZING THE PURCHASE OF ONE 2022 FORD EXPLORER POLICE PURSUIT VEHICLE  
AND EQUIPMENT AND REPLACE 2014 DODGE CHARGER AS PART OF FLEET  
MANAGEMENT, DISPENSING WITH THE SECOND READING  
AND DECLARING AN EMERGENCY**

**WHEREAS**, the Board of Trustees of Columbia Township, Hamilton County, Ohio, provides vehicles for use by the Hamilton County Sheriff for patrol and enforcement in the Township; and,

**WHEREAS**, a Columbia Township 2014 Dodge Charger Police Pursuit Car 72 is scheduled to be replaced in 2022 as the oldest fleet car; the replacement is funded in the 2022 Township budget and is based on the Sheriff's recommended fleet management cycle for vehicles with more than 100,000 miles that have higher downtime due to increasing maintenance and higher repair expenses; and,

**WHEREAS**, the Sheriff's Office has arranged for Columbia Township to take delivery of one 2022 Ford Explorer Police Pursuit vehicle as part of the Sheriff's Office purchase order at the original public bid price at or below market value; and,

**WHEREAS**, the Sheriff's Office estimates the total vehicle package cost to be \$33,414.14 as follows: \$28,217 for 2022 Ford Explorer Police Pursuit from Lebanon Ford (\$33,917 minus \$5,700 trade-in of 2014 vehicle); \$4,790.74 for Equipment Package from Parr Public Safety Equipment; and \$406.40 for Exterior Detailing Package from DanCo Lettering. The Township's net cost for the total vehicle package is \$18,414.14 after Ridge & Highland major employer CBT's annual \$15,000 township services grant; and,

**WHEREAS**, the Board, upon majority vote, hereby dispenses with the requirement that this resolution be read on two separate days, and hereby authorizes the adoption of this resolution upon its first reading; and,

**WHEREAS**, this Resolution is hereby declared to be an emergency measure necessary for the preservation of the public peace, health and welfare of the Township; the reason for the emergency is the Township must purchase the vehicles at the earliest possible time or will lose the opportunity during this extended COVID period of low national vehicle inventory; and,

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Trustees of Columbia Township, Hamilton County, Ohio, for the benefit and welfare of Columbia Township and its citizens, hereby authorizes the Administrator to spend up to \$33,414.14 for a 2022 Ford Explorer Police Pursuit Package.

- Purchaser warrants to Seller that Purchaser's trade-in vehicle does not have a "salvage", "flood", "lemon law buyback" or other type of branded title. Purchaser further warrants that the emission system on the trade-in vehicle is in proper operating condition and has not been modified in any manner. Seller reserves the right to reappraise or reduce the trade-in allowance if the trade-in value or condition has diminished between the time this contract was executed and Purchaser delivered the trade-in to Seller.
- None of the above Terms and Conditions shall be construed to limit Seller's legal remedies against Purchaser. This contract shall be construed under Ohio law.
