

RESOLUTION 22 -52, 2022
COLUMBIA TOWNSHIP, HAMILTON COUNTY, OHIO

**AUTHORIZING THE PURCHASE OF ONE 2022 SCAG TURF TIGER ZERO-TURN
COMMERCIAL RIDING MOWER FROM BRAMBLE MOWER FOR PUBLIC
GROUNDS MAINTENANCE, DISPENSING WITH THE SECOND READING,
AND DECLARING AN EMERGENCY**

WHEREAS, the Board of Trustees of Columbia Township, Hamilton County, Ohio provides for the maintenance of Township public grounds including road right-of-way, and maintains an inventory of grounds maintenance equipment; and

WHEREAS, the Maintenance Department recommends adding a second commercial mower to its equipment inventory to increase efficiency. As the Board of Trustees invests in additional community improvement initiatives, there are increased demands on crew scheduling. The new mower is a riding mower which can mow at higher speeds than the existing walk-behind mower. Also, two crew members can mow at the same time and complete the work more quickly; and

WHEREAS, the Maintenance Department recommends the purchase of a 2022 Scag Turf Tiger 61" commercial riding mower for \$14,878.50, as shown on the attached estimate, from Bramble Mower, 3830 Round Bottom Rd., Cincinnati, Ohio, 45244; and

WHEREAS, the Township relies on maintaining a suitable inventory of safe and operable industry-rated equipment in order for the services crew to perform a full schedule of public services, and such services are necessary for the public welfare of Township residents and businesses; and

WHEREAS, the Board, upon majority vote, hereby dispenses with the requirement that this resolution be read on two separate days, and hereby authorizes the adoption of this resolution upon its first reading; and,

NOW, THEREFORE, BE IT RESOLVED, the Board of Trustees of Columbia Township, Hamilton County, Ohio, for the benefit and welfare of Columbia Township and its citizens, deems it to be in the best interest of the Township to purchase said equipment and authorizes the Fiscal Officer to draw her warrant on the Township Treasury for payment from the foregoing appropriation upon receiving proper vouchers therefore, and approved by the Board of Trustees.

Be it further resolved that this Resolution is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety, and general welfare and shall be effective immediately. The reason for the emergency is that the available inventory of public works vehicles and equipment is nearly depleted due to pandemic impacts (supply chains and manufacturing) and cost inflation is increasing prices as often as monthly or even weekly. The vendor requires an immediate order to guarantee the proposal price against an increase and to provide delivery before mowing season begins in 2023.
