

RESOLUTION 23 - 34, 2023
COLUMBIA TOWNSHIP, HAMILTON COUNTY, OHIO

**ACCEPTING THE 2024 AMOUNTS AND RATES AS DETERMINED BY THE HAMILTON
COUNTY BUDGET COMMISSION, AUTHORIZING THE NECESSARY TAX LEVIES AND
CERTIFYING THEM TO THE COUNTY AUDITOR, DISPENSING WITH THE
SECOND READING, AND DECLARING AN EMERGENCY**

The Board of Trustees of Columbia Township, Hamilton County, Ohio, met in Regular Session on October 10, 2023, at the Columbia Township Administration Building, 5686 Kenwood Road, Cincinnati, Ohio with the following members present:

WHEREAS, the Board of Trustees of Columbia Township in accordance with the provisions of law has previously adopted a Tax Budget for the next succeeding fiscal year commencing January 1st, 2024; and,

WHEREAS, the Budget Commission of Hamilton County, Ohio has certified its action thereon to this Board together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Board and what part thereof is without, and what part within the ten-mill limitation; and,

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Columbia Township, Hamilton County, Ohio, for the benefit and welfare of Columbia Township and its citizens that the amounts and rates, as determined by the Budget Commission in its certification, be and the same are hereby accepted; and be it further,

RESOLVED, that there be and is hereby levied on the tax duplicate of Columbia Township the rate of each tax necessary to be levied within the ten-mill limitation as attached; and be it further,

RESOLVED, that the Clerk of this Board is hereby directed to certify a copy of this Resolution to the County Auditor of Hamilton County.

WHEREAS, the Board, upon majority vote, hereby dispenses with the requirement that this resolution be read on two separate days, and hereby authorizes the adoption of this resolution upon its first reading; and,

WHEREAS, this Resolution is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, and welfare of the Township; the reason for the emergency is the Township must certify the tax amounts and rates to the County Auditor by October 25, 2023.
