

RESOLUTION 23 – 35, 2023
COLUMBIA TOWNSHIP, HAMILTON COUNTY, OHIO

**AUTHORIZING THE ADMINISTRATOR TO PURCHASE NO PARKING SIGNS AND
POLES FOR ASHLEY OAKS, FROM KLEEM INC., AND ACCEPT REIMBURSEMENT
FROM WILLIAMS MEADOW HOA, AND DISPENSING WITH THE SECOND READING**

WHEREAS, Columbia Township is authorized by Ohio Revised Code §505.17 to make such regulations as are necessary to control vehicle parking in the unincorporated area of the Township, and further is authorized under the Ohio Manual of Uniform Traffic Control Devices (OMUTCD) to establish No Parking areas; and

WHEREAS, By Resolution 22-35 and 23-28, the Board previously established No Parking at the entrance of Ashley Oaks to improve safety for motorists entering and exiting US-50 and north to the intersection at Ashley View. TEC, the Township's transportation safety engineering consultant, conducted a safety study of conditions which recommended establishing the No Parking area; and

WHEREAS, the Administrator recommends that the Board of Trustees accept the attached \$17,013.56 total quote from Kleem Inc., 6370 Gano Rd., West Chester, Ohio, 45069, for 12 No Parking signs, décor poles, and installation. Columbia Township will be responsible for the \$5,722.32 cost of No Parking signs and installation, and the Williams Meadow Homeowners' Association will reimburse the Township \$11,291.24 for the décor poles; and

WHEREAS, the Board, upon majority vote, hereby dispenses with the requirement that this resolution be read on two separate days, and hereby authorizes the adoption of this resolution upon its first reading.

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of Columbia Township, Hamilton County, Ohio, for the benefit and welfare of Columbia Township and its citizens, hereby accepts the Kleem Inc quote; and further authorizes the Administrator to purchase the No Parking sign and installation package from Kleem Inc. in the amount of \$17,013.56 and accept reimbursement from Williams Meadow HOA in the amount of \$11,291.24.





