AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO ENTER INTO A CONTRACT WITH SILCO FOR FIRE & SECURITY, ACCESS CONTROL, AND INTERIOR/EXTERIOR CAMERA SECURITY FOR THE MADISON PLACE FIREHOUSE REDEVELOPMENT PROJECT, AND DISPENSING WITH THE SECOND READING

WHEREAS, the Board of Trustees desires to contract for a professional commercial fire and security system services for the Madison Place Firehouse redevelopment into a multipurpose community, senior, and event center, town hall, and small office space to include township administrative offices ("Project"); and

WHEREAS, the Project specifically requires systems for fire, access control, and security including exterior and interior cameras; and

WHEREAS, the Township's Project Manager sought proposals for the required systems, of the respondents, recommends Silco Fire & Security ("Silco"), 10200 Reading Rd., Cincinnati, Ohio, 45241. Silco is an industry expert in commercial building fire, access control, and security systems in Ohio and has specialized expertise in fire house structures; and

WHEREAS, Silco proposes to design and install the Project fire and security system for \$44,500; the access control system for \$20,432; and the exterior/interior camera security system for \$8,047; the total proposal cost is \$72,979 as detailed in the attached proposals. Silco agreed to guarantee the 2023 proposal pricing through the 2024 Project construction; and

WHEREAS, the Silco costs for Project installation are eligible to be paid from the Plainville TIF Fund 2406; and

WHEREAS, the Board of Trustees, upon majority vote, hereby dispenses with the requirement that this Resolution be read on two separate days, and hereby authorizes the adoption of this Resolution upon its first reading.

NOW, THEREFORE, BE IT RESOLVED, the Board of Trustees of Columbia Township, Hamilton County, Ohio, for the benefit and welfare of Columbia Township and its citizens hereby authorizes the Township Administrator, on behalf of the Township, to accept all proposals by Silco Fire & Security and Columbia Township for fire, access control, and security systems services for the Madison Place Firehouse Redevelopment Project.
