

RESOLUTION 24 - 08, 2024
COLUMBIA TOWNSHIP, HAMILTON COUNTY, OHIO

**DESIGNATING ON-STREET PARALLEL PARKING SPACES ON THE
SOUTH SIDE OF EAST MURRAY AVENUE BETWEEN
PLAINVILLE ROAD AND BERWICK AVENUE**

WHEREAS, the Township may regulate parking within the Township under Ohio Revised Code Section 505.17 and Ohio Home Rule, and this authority includes establishing and regulating parking on public streets and right-of-way; and

WHEREAS, the Board of Trustees desires to exercise its authority and authorize on-street parallel parking on East Murray Avenue which, before 2020, had not been properly identified as Columbia Township-owned right-of-way; and

BE IT RESOLVED, by the Board of Trustees of Columbia Township, Hamilton County, Ohio, as follows:

SECTION 1-A:

The Board declares that nine parking spaces shall be designated on the south side of East Murray Ave. between Plainville Rd. and Berwick Ave. within the Township as designated by the Township's transportation engineer TEC Engineering on the attached plan; and

SECTION 1-B:

The Board authorizes the Roads Superintendent to publicize this parking directive per applicable requirements and to display the appropriate signage notifying the public of this directive, and authorizes the Hamilton County Sheriff's Office to enforce the regulation as provided under the Ohio Revised Code.

SECTION 2:

This resolution shall take effect at the earliest time provided by Ohio law.

SECTION 3:

It is hereby determined that all formal actions of the Board of Trustees relating to the adoption of this Resolution were taken in an open meeting of the Board of Township Trustees and that all deliberations of such Board of Trustees were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


