

**RESOLUTION 24 - 16, 2024**  
**COLUMBIA TOWNSHIP, HAMILTON COUNTY, OHIO**

**AUTHORIZING PURCHASE OF UP TO 200 TONS OF ROAD SALT AT \$78.22  
PER TON FOR THE 2024-25 WINTER SEASON, DISPENSING WITH THE SECOND  
READING, AND DECLARING AN EMERGENCY**

**WHEREAS**, the Board of Trustees is authorized to remove snow and ice from township roads to protect the lives and property of residents and other persons traveling within the Township; and

**WHEREAS**, Columbia Township has the option to secure road salt at a lower price each spring through summer before prices increase in October; the Board desires to purchase salt for the 2024-25 winter season through the City of Cincinnati contract with Morton Salt, 2625 Butterfield Rd., Suite 208E, Oakbrook, IL 60523, which meets all applicable state and local bidding requirements (refer to attachment); and,

**WHEREAS**, this resolution is an emergency necessary for the preservation of the public peace, health, safety, or welfare to save money and expediate the bidding process to purchase salt at \$78.22/ton while supplies are available; and

**WHEREAS**, the Board of Trustees, upon majority vote, hereby dispenses with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

**NOW, THEREFORE, BE IT RESOLVED**, the Board of Trustees of Columbia Township, Hamilton County, Ohio, for the benefit and welfare of Columbia Township and its citizens, hereby approves the purchase of up to 200 tons of road salt from Morton Salt at \$78.22/ton for up to \$15,644. Recent annual salt price increases have been:

2024 - 4% increase

2023 - 5% increase

2022 -3% increase

**BE IT FURTHER RESOLVED**, that the Township Administrator and/or Road Superintendent are authorized to sign and file all documents associated herewith as prepared by the Road Superintendent.





**ROAD SALT BULK DELIVERY AND PICKUP**

The City's current obligation for purchase is 13,704 tons at \$72.48/ton (4% increase).

The City's estimate for the 2024-2025 season is zero new tons.

Morton Salt, Inc. has agreed to provide the City up to an additional 7,000 tons at a price of \$79.73/ton with no minimum order quantities above the current obligation.

Price per ton for participating municipalities is \$78.22 for the 2024-2025 season.

It is the intent of both the City of Cincinnati and Morton Salt, Inc. that this will be the last season that this contract will be active. If the City does not take delivery of all 13,704 tons by April 30, 2025, the City and Morton's Salt, Inc. will negotiate a final cost or delivery schedule and the contract will terminate. These negotiations and termination will be formalized in a Change Order.
