### RESOLUTION 24 - 31, 2024 COLUMBIA TOWNSHIP, HAMILTON COUNTY, OHIO

# PROVIDING FOR AND AUTHORIZING THE ABATEMENT, CONTROL, OR REMOVAL OF VEGETATION, GARBAGE, REFUSE, AND OTHER DEBRIS, DECLARING A NUISANCE FOR THE NON-COMPLIANT PROPERTIES, DISPENSING WITH THE SECOND READING, AND DECLARING AN EMERGENCY

WHEREAS, Ohio Revised Code §505.87 provides that a Board of Township Trustees may provide for the abatement, control, or removal of vegetation, garbage, refuse, and other debris ("Nuisance or Nuisance Conditions") from land located in the township; and

**WHEREAS,** the Board of Township Trustees of Columbia Township has determined that the owner's maintenance of vegetation, garbage, refuse, or other debris constitutes a nuisance at:

WHEREAS, the non-compliant properties have garbage, refuse and/or other debris, tall grass, and weeds in excess of the length permitted; these Nuisance Conditions are violations of Columbia Township's Exterior Property Maintenance Code, Article V and/or Article VI, as shown in the attached Columbia Township Notice of Property Maintenance Violation(s) with photos.

**NOW THEREFORE, BE IT RESOLVED** by the Board of Township Trustees, Columbia Township, Ohio:

- **Section 1.** That the tall grass, and weeds in excess of eight (8) inches, and garbage, refuse and other debris located on the subject non-compliant properties are hereby declared to be a nuisance.
- **Section 2.** Pursuant to O.R.C. §505.87, the owner and lien holders of record for the properties shall be properly notified of this action and given seven days to abate the nuisance.
- <u>Section 3.</u> In the event the nuisance is not abated within the time period allowed, the Columbia Township Maintenance Department is hereby directed to remove the tall grass, weeds, and discard of all garbage, refuse and other debris or contract for the removal of the tall grass, weeds, and discard all garbage, refuse and other debris from the subject non-compliant properties.
- **Section 4.** By a separate resolution of the Board of Township Trustees, the owners of the subject nuisance properties shall be billed for such services, and the Fiscal Officer shall place a special assessment on the real estate tax bill of the properties if payments are not made within 30 days.

- **Section 5.** The Board of Township Trustees, Columbia Township upon majority vote do hereby dispense with the requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.
- **Section 6.** This Resolution is hereby declared to be an emergency measure necessary for the preservation of the public peace, health and welfare of the Township. The reason for the emergency being the immediate need to abate the Nuisance Conditions existing at the Properties at the earliest possible time.
