AMENDING RESOLUTION 22-58 AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO ENTER INTO A CONTRACT WITH COLUMBIA SMALL BUSINESS HOWARD'S KITCHEN STUDIO FOR A CABINETRY PACKAGE FOR THE MADISON PLACE FIREHOUSE GOVERNMENT & COMMUNITY CENTER, DISPENSING WITH THE SECOND READING, AND DECLARING AN EMERGENCY.

A STATE AND A STATE

WHEREAS, Columbia Township is redeveloping the vacant former Madison Place Firehouse to be placed back into productive public use as a community and senior event center and Township meeting hall and administration office. The Township to date has secured more than \$500,000 in redevelopment grants and created a Tax Increment Financing District to cover certain eligible costs of the project; and

WHEREAS, on November 8, 2022, the Columbia Township Board of Trustees approved Resolution 22-58 authorizing a contract with Columbia-based business Howard's Kitchen Studio for a cabinetry package for the future Government & Community Center ("Project"); and

WHEREAS, Project construction pushed to 2024 due to pandemic-related materials and labor delays; Howard's Kitchen Studio's original commercial-grade cabinetry proposal, based on preliminary facility design, has been updated to \$31,084.42 based on final design and as-built measurements from the 2022 pricing of \$26,700; and

WHEREAS, the Board of Trustees, upon majority vote, hereby dispenses with the requirement that this Resolution be read on two separate days, and hereby authorizes the adoption of this Resolution upon its first reading; and

WHEREAS, this is an emergency resolution necessary for the immediate preservation of the public peace, health, safety, or welfare of the Township; the reason for the emergency being the immediate need to authorize the Administrator to approve the attached proposal from Howard's Kitchen Studio at a cost not to exceed \$31,084.42 and to take other steps as necessary at the soonest possible time to meet the Project construction schedule.

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of Columbia Township, Hamilton County, Ohio, for the benefit and welfare of the Township and its citizens, hereby authorizes the Administrator to sign a purchase contract with Howard's Kitchen Studio for up to \$31,084.42 for a commercial-grade cabinetry package for the Columbia Government & Community Center.

In no event shall **HOWARD's KITCHEN STUDIO** be liable for any consequential, indirect, incidental or special damages of any nature arising from the sale or use of the product, whether in contract, tort, strict liability or otherwise. THE warranty shall become effective when signed by **HOWARD's KITCHEN STUDIO** and delivered to the CLIENT.

3) EQUIPMENT, materials and labor not included in these specifications can be furnished by HOWARD's KITCHEN STUDIO as extras at an additional cost.

ALL CHANGES MUST FIRST be APPROVED by HOWARD'S KITCHEN STUDIO and MUST BE REQUESTED in WRITING.

PAYMENT for SUCH ITEMS ARE DUE in FULL AT TIME of ORDER.

4) IF CHANGES are made by the CLIENT after signing off on drawings and contract, charges for redesign and cabinetry will be at the CLIENTS' expense.

All dimensions and size designations given on the floor plan, which are part of these specifications, are subject to verification on jobsite and are subject to adjustments dictated by the jobsite conditions and unforeseen items.

HOWARD's KITCHEN STUDIO makes every effort to properly estimate the amounts of moldings, toe board, etc., that the project will require, but in the event any additional materials are needed to complete the project, they will be at the CLIENTS expense. The cost of any unused overage of material, moldings, etc., CANNOT BE CREDITED back to the Client.

5) IF specifications call for reuse of existing equipment, or if the CLIENT is to furnish materials, HOWARD's KITCHEN STUDIO will not guarantee the operation and / or appearance of those items. - 12) UPON the substantial installation of materials that have been set forth in this agreement, the CLIENT agrees to pay HOWARD's KITCHEN STUDIO the remainder of payments due to satisfy this contract. TITLE to items sold pursuant to this agreement shall not pass to the CLIENT until full price, as set forth in this agreement, has been received by HOWARD's KITCHEN STUDIO.
- 13) Delays in payment shall be subject to interest charges of (11%) per annum, and in no event higher than the interest rate provided by law. IF HOWARD's KITCHEN STUDIO is required to engage the services of a collection agency or an attorney, the CLIENT agrees to reimburse HOWARD's KITCHEN STUDIO for any reasonable amount expended in order to collect the unpaid balance.
- 14) This agreement sets forth the entire transaction between the parties; any and all prior agreements, warranties or representations made by either party are superseded by this agreement. All changes in this agreement shall be made by a separate document and executed with the same formalities. No agent of HOWARD's KITCHEN STUDIO, UNLESS AUTHORIZED IN WRITING by HOWARD's KITCHEN STUDIO, HAS ANY AUTHORITY to waive, alter, or enlarge this agreement, or to make any new, substituted or different contracts, representations or warranties.

Upon delivery of the major portion of this agreement, the amount due for any damaged or undelivered product(s) may be delayed until that product (s) is delivered. Any unresolved controversy or claim arising from this agreement, shall be settled by arbitration and judgment, the award rendered may beentered in any court of competent jurisdiction. The arbitration shall be held under the rulesof American Arbitration Association.
