AUTHORIZING THE ADMINISTRATOR TO AWARD ONE-TIME DISCRETIONARY BONUSES TO RECOGNIZE EMPLOYEE EXEMPLARY PERFORMANCE, PAID FROM NON-LEVY FUNDING SOURCES, AND DISPENSING WITH THE SECOND READING

WHEREAS, the Columbia Township Board of Trustees recognizes that dedicated Township hourly employees are called upon to work in a challenging 24/7 environment facing often difficult circumstances to deliver essential public services to residents and businesses; and

WHEREAS, the Board desires to recognize, encourage, and reward outstanding employees for job performance that well exceeds the usual expectations for their positions, and demonstrates the Township's interest in retaining high performing employees, by authorizing the Administrator to award one-time, discretionary bonuses; and

WHEREAS, the one-time, lump-sum bonus is to be paid only from Township discretionary (unrestricted), non-levy funds sourced from marijuana dispensary fees; and

WHEREAS, the Board of Trustees, upon majority vote, hereby dispenses with the requirement that this Resolution be read on two separate days, and hereby authorizes the adoption of this Resolution upon its first reading.

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of Columbia Township, Hamilton County, Ohio, hereby adopts this policy to govern the awarding of one-time, lumpsum compensation that is outside of an employee's base salary or wages to reward exemplary performance and authorizes the Administrator a total budget of up to \$21,000:

- <u>Section 1:</u> Bonus policy will apply to wage employees only
- <u>Section 2:</u> A bonus will be a one-time payment, will not be added to base salary, will be processed through the payroll system, and all applicable deductions and federal state tax contributions will be taken
- <u>Section 3:</u> Bonuses will be made at the Township Administrator's sole discretion. Consideration for a bonus shall be based on factors that include, but are not limited, to:

(a) Exemplary work on a special project, program, or service

(b) Achievement of significant Township goals for community engagement, support, and public service delivery

(c) Developing or assisting with implementing an idea or an initiative which improves an administrative or public service process, results in cost-savings, or
