RESOLUTION 25 - 09, 2025 COLUMBIA TOWNSHIP, HAMILTON COUNTY, OHIO

AMENDING RESOLUTION 24-72 REQUESTING THE COUNTY AUDITOR TO MAKE ADVANCE PAYMENT OF TAXES DUE IN ANY SETTLEMENT OF 2025, AND DISPENSING WITH THE SECOND READING

WHEREAS, the Ohio Revised Code allows a taxing authority to request payment from the County Auditor funds derived from taxes or other sources to the County Treasurer, which may be held on account of a local subdivision;

WHEREAS, the Columbia Township Board of Trustees approved Resolution 24-72 on December 7, 2024, requesting the Hamilton County Auditor to make advance payments of taxes due in any 2025 real property tax settlements; and

WHEREAS, the Trustees desire to add Township Finance Director Krista Blum as an additional authorized Columbia Township representative to request in writing to draw and pay funds due in any 2025 settlement.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Columbia Township, Hamilton County, Ohio, for the benefit and welfare of Columbia Township and its citizens:

Section 1. That the Auditor and the Treasurer of Hamilton County, in accordance with Ohio Revised Code § 321.34, be requested to draw and pay to Columbia Township, Hamilton County, upon the written request of Fiscal Officer Caroline Heekin, Township Administrator Melissa Taylor, or Finance Director Krista Blum to the County Auditor, funds due in any settlement of 2025 derived from taxes or other sources, payable to the County Treasurer to the account of Columbia Township, Hamilton County, and lawfully applicable for purposes of fiscal year 2025.

Section 2. That the Fiscal Officer, Township Administrator, or Finance Director of Columbia Township, Hamilton County, shall forward to the County Auditor a certified copy of this Resolution.

Section 3. Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and authorizes the adoption of this Resolution upon its first reading.

Section 4. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
