AUTHORIZING A CHANGE ORDER TO FORD DEVELOPMENT CONSTRUCTION CONTRACT FOR 6805 CAMBRIDGE AVENUE – BUSINESS DISTRICT PARKING LOT, DISPENSING WITH THE SECOND READING, AND DECLARING AN EMERGENCY

WHEREAS, the Board of Trustees approved Resolution 23-11 on April 30, 2025, to award the construction of the Cambridge Ave. East Improvement to the lowest responsive and responsible bidder Ford Development Corp., 11148 Woodward Lane, Sharonville, Ohio 45241 ("Contractor"); and

WHEREAS, the Cambridge Ave. East Improvement bid includes construction of Cambridge Ave. East roadway improvements and to 6805 Cambridge Ave. to become a Township-owned parking lot ("Project") as detailed in Resolution 25-11; and,

WHEREAS, Columbia's Transportation Engineer, TEC Consulting, has determined, upon further study following the initial Project design, and in consultation with the Contractor, that the parking lot stormwater system needs to be modified; specifically, the surface slope is not sufficient to route drainage from the 6896 Murray public walkway easement to the parking lot system. TEC recommends directing the walkway drainage instead to the Hamilton County stormwater pipe under Murray Ave.; and

WHEREAS, Columbia's Road Superintendent and Administrator agree with TEC's proposed change and recommend that the Board of Trustees authorize \$57,000.00 for the change order to be made to the Contractor contract, as detailed in the attached document; and;

WHEREAS, the Board of Trustees, upon majority vote, hereby dispenses with the requirement that this Resolution be read on two separate days, and hereby authorizes the adoption of this Resolution upon its first reading.

NOW, THEREFORE, BE IT RESOLVED, the Board of Trustees of Columbia Township, Hamilton County, Ohio, for the benefit and welfare of the Township and its citizens, hereby authorizes the Township Administrator to accept the Ford Development Construction contract change order as detailed totaling \$57,000.00 for the Cambridge Ave. East Improvement Project.

WHEREAS, this is an emergency resolution necessary for the immediate preservation of the public peace, health, safety, or welfare of the Township; the reason for the emergency being the immediate need to authorize the Administrator to accept the construction contract change orders and take other necessary steps at the soonest possible time to keep the Project on schedule and specifically to meet state and county grant requirements.
