# PETITIONING THE HAMILTON COUNTY BOARD OF COMMISSIONERS TO VACATE A PORTION OF BUFLER LANE AND ENTIRE LENGTH OF ELLMARIE DRIVE TO THE SEVEN HILLS SCHOOL; DISPENSING WITH THE SECOND READING; AND DECLARING AN EMERGENCY

WHEREAS, the Columbia Township Board of Trustees desires to vacate the final remaining public segment of Bufler Lane and the entire length of Ellmarie Drive in the Township to The Seven Hills School, or its designee, to facilitate the continued expansion of Seven Hills School and specifically for the current expansion of the Early Childhood Education Center; and

WHEREAS, Hamilton County Zoning this year approved Seven Hills School's application to expand its Early Childhood Education Center which the Columbia Township Trustees also endorsed; and

WHEREAS, Columbia Township's crew continues to provide public services for Bufler Lane and Ellmarie Drive, including snow/ice removal, street sweeping, leaf and brush collection, storm drain and catch basin inspections, and road repairs, but only three houses remain from the original neighborhood which are all owned by Seven Hills; and

WHEREAS, the Bufler Lane portion to be vacated totals 0.242 acres, as set forth on the attached plat (Exhibit A) and described in the attached Legal Description (Exhibit B), and is the last remaining segment of Bufler Lane owned by the Township, and the totality of Ellmarie Drive to be vacated is 1.066 acres as set forth on the attached plat (Exhibit A) and described in the attached Legal Description (Exhibit C); and

WHEREAS, the final segment of Bufler Lane and the entirety of Ellmarie Drive, streets located in Columbia Township, Hamilton County, Ohio, will no longer be used to calculate distributions of the auto registration distribution fund and will not be a road certified by the Columbia Township Board of Trustees to the Ohio Director of Transportation as mileage used by and maintained for the public; and

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of Columbia Township, Hamilton County, Ohio as follows:

1. The Board directs the Columbia Township Fiscal Officer to certify a copy of this resolution to the Hamilton County Board of Commissioners and to the Hamilton County Engineer; and

- 2. The Board specifically requests, pursuant to Ohio Revised Code Section 5553.045, that the Hamilton County Board of Commissioners vacate the final segment of Bufler Lane and the entirety of Ellmarie Drive as depicted in the attached Exhibits A, B, and C (which include a description of the general route and termini of the roads to be vacated; and
- 3. The Board specifically requests, pursuant to Ohio Revised Code Section 5553.045, that the Hamilton County Engineer should issue its report to the Hamilton County Board of Commissioners regarding vacation of Bufler Lane and Ellmarie Drive; and
- 4. That it is hereby found and determined that all formal actions of this Board concerning to and relating to the passage of this Resolution were taken in an open meeting of this Board and that all deliberations of this Board that resulted in such formal action were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code; and
- 5. That the Board by a majority vote hereby dispenses with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of the Resolution upon its first reading; and
- 6. That this Resolution is an emergency measure, necessary for the immediate preservation of the public peace, health, safety, and welfare of the Township because vacating the roadways to the non-profit school at the earliest possible time provided by law will allow Columbia Township to stop providing numerous public services that are paid from levies.


