## RESOLUTION 23 – 12, 2023 COLUMBIA TOWNSHIP, HAMILTON COUNTY, OHIO

AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO ENTER INTO A CONTRACT WITH STRUCTURAL SYSTEMS REPAIR GROUP FOR STRUCTURAL MASONRY REPAIRS FOR THE MADISON PLACE FIREHOUSE REDEVELOPMENT PROJECT, DISPENSING WITH THE SECOND READING, AND DECLARING AN EMERGENCY.

WHEREAS, the Board of Trustees desires to contract for professional commercial structural masonry repair services for the Madison Place Firehouse redevelopment into a multipurpose community, senior, and event center, town hall, and small office space to include township administrative offices ("Project"); and

WHEREAS, the Firehouse was built in 1950, and over the decades its concrete block and masonry brick structure has deteriorated in several areas that were not maintained or repaired as necessary by the former owner. The Firehouse masonry structure must be stabilized before the Township can proceed to renovate the building; and

WHEREAS, the Township's Project Manager sought proposals for masonry repairs and, of the respondents, recommends Structural Systems Repair Group ("SSRG"), 2824 Stanton Ave., Cincinnati, 45206. SSRG is an industry expert in structural stabilization of commercial historic masonry buildings like the Firehouse which have deteriorated joints and failing lintels; and

WHEREAS, SSRG proposes to perform structural stabilization of the firehouse through repair and installation of horizontal and vertical expansion joints, removal and replacement of cracked or distressed brick, shelf angle and lintel replacement/restoration, and repointing of deteriorated mortar joints for \$36,387 as detailed on the attached proposal; and

WHEREAS, the Board of Trustees, upon majority vote, hereby dispenses with the requirement that this Resolution be read on two separate days, and hereby authorizes the adoption of this Resolution upon its first reading.

**NOW, THEREFORE, BE IT RESOLVED,** the Board of Trustees of Columbia Township, Hamilton County, Ohio, for the benefit and welfare of Columbia Township and its citizens hereby authorizes the Township Administrator to sign, on behalf of the Township, an agreement between Structural Systems Repair Group and Columbia Township for structural masonry stabilization services for the Madison Place Firehouse Redevelopment Project.

WHEREAS, this is an emergency resolution necessary for the immediate preservation of the public peace, health, safety, or welfare of the Township; the reason for the emergency being the immediate need to authorize the Administrator to enter into the contract Structural Systems Repair Group and take other necessary steps at the soonest possible time to keep the Project on schedule and specifically to meet state and county grant requirements.

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Trustees of Columbia Township, Hamilton County, Ohio, for the benefit and welfare of the Township and its citizens, hereby

  - c. Assumes no interior demo necessary for replacement
  - d. Brick to be salvaged for re-use
  - e. Mortar to best match existing in color and composition
- 2. Repairs at garage door openings 2 EA
  - a. Removal of masonry inside of web of steel
  - b. Wire brush removal of rust
  - c. Application of cold-galvanizing paint
  - d. Replacement of masonry in kind
    - i. Assumes use of salvaged brick
    - ii. Mortar to best match existing in color and composition
