

**RESOLUTION NO 21-02, 2021
COLUMBIA TOWNSHIP, HAMILTON COUNTY, OHIO**

**REQUESTING THE COUNTY AUDITOR TO MAKE
ADVANCE PAYMENT OF TAXES, DISPENSING WITH THE SECOND READING
AND DECLARING AN EMERGENCY**

WHEREAS, the Ohio Revised Code allows a taxing authority to request payment from the County Auditor of funds derived from taxes or other sources to the County Treasurer, which may be held on account of a local subdivision; and

WHEREAS, the Board, upon majority vote, hereby dispenses with the requirement that this resolution be read on two separate days, and hereby authorizes the adoption of this resolution upon its first reading; and,

WHEREAS, this Resolution is hereby declared to be an emergency measure necessary for the preservation of the public peace, health and welfare of the Township; the reason for the emergency is the Township may utilize funds due to it at the earliest possible time without waiting for the twice-a-year Auditor's settlement.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Columbia Township, Hamilton County, Ohio, for the benefit and welfare of Columbia Township and its citizens:

Section 1. That upon the written request of Caroline Heekin, Fiscal Officer, or Melissa Taylor, Township Administrator, the Auditor and the Treasurer of Hamilton County, in accordance with Ohio Revised Code § 321.34, shall draw and pay to Columbia Township, Hamilton County, funds due in any settlement of 2020 derived from taxes or other sources, payable to the County Treasurer to the account of Columbia Township, Hamilton County, and lawfully applicable for purposes of fiscal year 2021.

Section 2. That the Fiscal Officer or Township Administrator of Columbia Township, Hamilton County shall forward to the County Auditor a certified copy of this Resolution.


